Primary Purpose of the Role

The Conservation and Research Coordinator is a full-time, cross-functional position that bridges the interface between biodiversity science and community conservation. The incumbent will lead the coordination of ORKCA's landscape-wide biodiversity monitoring program with a strong research and data collection component, while supporting integrated community engagement across the Greater ORKCA landscape. This role ensures the alignment of conservation science, ecological restoration, and socio-economic development objectives by working closely with local communities, research partners, and the broader ORKCA team.

Key Responsibilities

1. Biodiversity Monitoring and Research

- Lead biodiversity and ecological monitoring activities across the ORKCA landscape in collaboration with Natural State and other research institutions.
- Develop and implement scientifically sound methodologies for BioCredit and biodiversity monitoring as per the Rolex Perpetual Planet Grant requirements.
- Coordinate field research and data collection on species, soil, vegetation, and water systems, with a focus on endangered plant species.
- Maintain and analyze datasets to inform adaptive management and reporting.
- Provide interim and final reports for internal use, external donors, and academic dissemination.

2. Community Engagement and Outreach

- Serve as the primary liaison between ORKCA and communities including the //Gamaseb Conservancy and Warmbad Community.
- Facilitate participatory conservation planning, ensuring integration of community priorities and traditional knowledge in ORKCA programs.
- Organize and facilitate community meetings, workshops, trainings, and awareness campaigns.
- Develop and manage community-led conservation projects and provide support in conflict resolution, governance, and benefit-sharing frameworks.
- Monitor and document changes in community perceptions and behaviors towards conservation.
- Coordinate and liaise with key partners and line ministries including Traditional Authorities and various other structures.

3. Programme & Project Coordination

- Manage community-linked biodiversity and research projects, including developing work plans, timelines, budgets, and deliverables.
- Ensure the timely implementation of the Rolex Perpetual Planet pilot and other strategic projects across the landscape.
- Track project impact and progress through measurable indicators and ensure all grant reporting obligations are met.

4. Capacity Building and Leadership Development

- Facilitate training workshops and field demonstrations on conservation, monitoring techniques, and enterprise development.
- Mentor community youth and local monitors involved in ecological restoration and data collection.
- Build strategic partnerships with educational institutions, NGOs, and government agencies to support local capacity.

5. Administration, Communications and Stakeholder Support

- Maintain up-to-date project records, including technical reports, data logs, and communication materials.
- Contribute content to ORKCA communications platforms highlighting conservation milestones and community successes.
- Engage constructively with external stakeholders, including government departments, donors, and researchers.
- Support the development of grant applications, budgets, and donor proposals in collaboration with ORKCA management.
